1. Purpose

To notify all current and potential licensees about the opening of the licensing window for the financial year 2025-2026 from the **03 March 2025 to 31 March 2025**.

2. Approvals

As per Boxing Act and Regulations, the decision to approve or reject license application/s rests with the Board of Boxing South Africa. Therefore, prospective licensees should ensure that their applications are submitted before the deadline.

All applications must be done online and no manual applications will be processed. The online application is available on the Boxing SA website (www.boxingsa.co.za) under licensing. Those applicants with challenges must contact Provincial Managers at their respective provinces or the office (mncedisi@boxingsa.co.za) to be assisted for their applications. 3. 2025/2026 License Tariffs

The applicants must take note of the tariffs below and must pay according to the correct category of the license that one wish to apply for.

NB:

- **Female SA Champions are exempted from the R900 champion's fee and only pay R300.**
- **Ensure that your payment is processed via the licensing system and not directly into any bank account.**
- **Your status should indicate "Awaiting Board Review" as confirmation of successful payment.**
- **It is important to upload correctly scanned documents, not photographs of documents.**

NB: Kindly note that any application that has been processed after the due date will be regarded as a late application. The Board Meeting to consider new and renewal of applications will seat on the second week of April 2025 and late applications will be considered on the second board meeting that will seat only in July 2025. We encourage applicants to process their applications on time and not wait for the last minute.
