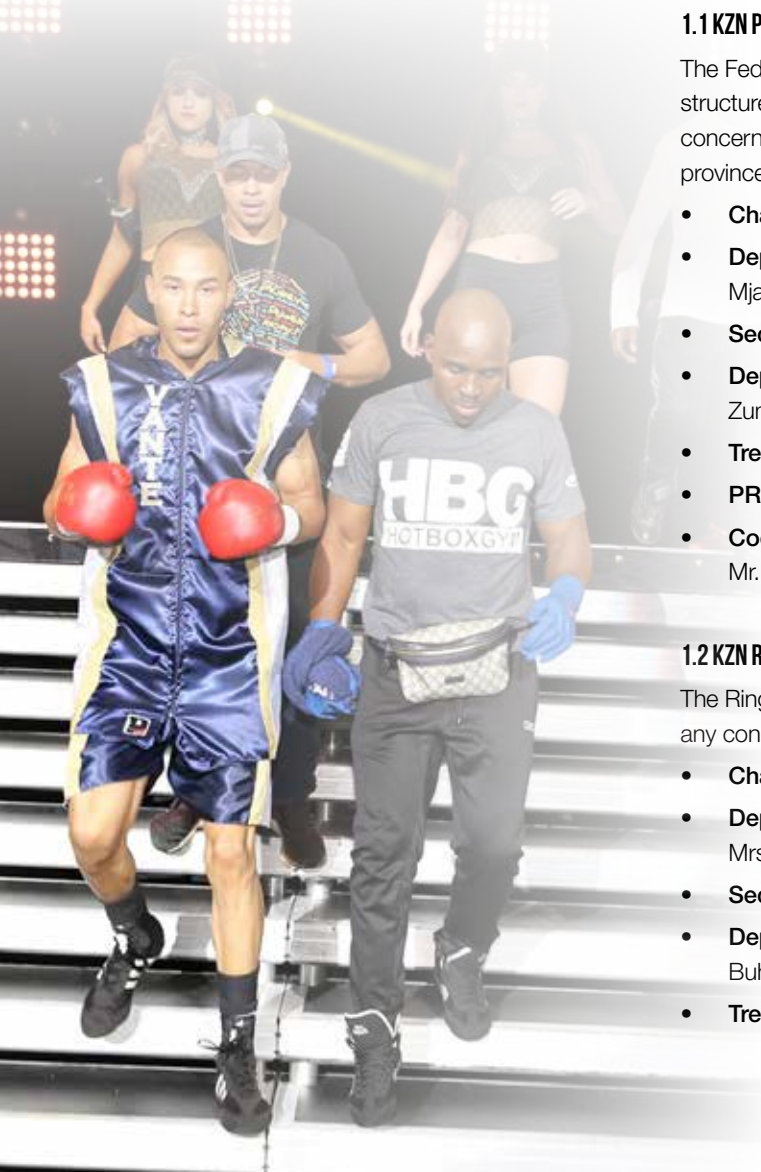

2. BSA AND SABC SPORT RAVISHING KNOT CONTINUES TO PUT SA BOXING IN THE LIMELIGHT

In the second phase of Memorandum of Understanding (MOU) between BSA and South African Broadcasting Cooperation (SABC), BSA is glad to announce that they have reached an agreement regarding the dates for tournaments.

The bouts will take place in different provinces from 27 October 2023 to 29 March 2024.

BSA and SABC aim to take boxing fights back to South Africans through the television broadcasting and give well-deserved exposure to the Boxers and Promoters.

The Promoters are welcome to bid on the given dates to ensure that they have enough time to prepare their tournaments and logistics.

National Secretary of Professional Boxing Promoters Association, Zandile Malinga, said they appreciate BSA and SABC's effort regarding this initiative.

"We really appreciate BSA and SABC's efforts to broadcast boxing. BSA made this their priority to bring boxing to the public broadcaster - to our viewers at home, because we are making Champions and we want them to reach fame and fortune! We also hope that these Champions will come to understand that they are role models to viewers everywhere," said Malinga.

Malinga believes that BSA and SABC are showing that they prioritise national as well as provincial fights.

"SABC and BSA are prioritising the SA national and provincial titles. By this, boxers are encouraged to fight and win at home before they go out of the country.

"We really appreciate that this initiative is happening. By rolling out the dates, it has become a reality," Malinga added. 🇿🇦

3. EASTERN CAPE GOVERNMENT'S PARTNERSHIP WITH BSA CONTINUES TO BOOST THE FINANCIAL MUSCLE OF THE BOXING DEVELOPMENT IN THE PROVINCE


The Eastern Cape Government has rolled out a grant for the development of boxing in the province.

This grant hopes to increase the number of boxing activities and assist promoters in their endeavors to unearth talent that will reinstate the pride of boxing in the Eastern Cape.

The province will see several bouts in the development stage.

"We are very happy as the province because it is going to give the Promoters a chance to stage tournaments.

"We are getting four tournaments from the department, so four Promoters will be able to do tournaments this financial year. We will also add three professional tournaments that will be aired by SABC, making it seven tournaments. It is a lot of work that will take place and will give the Boxers something to hope for," said The Eastern Cape Promoter's Association Secretary, Sibongile Matiti Mpofu.

Mpofu, who is already enthusiastic about boxing development in the province, insists this grant will also contribute to the growth of more women in the sport of boxing. 



4. THE RISE OF WOMEN IN BOXING SETS TO STAGE FIRST CLASS ACTION IN SERIES THREE AND FOUR

Following a successful Series of the Rise of Women in Boxing that took place in North West on the 16th and 17 September 2023, the committed BSA will move to Limpopo for Series Three.

BERNICE FERREIRA (SA) VS CECILIA PITISENI (ZIM)

Bernice Ferreira will be hoping to continue with her winning streak after registering 3 Wins in as many Fights. But first she will have to overcome the tough-as-nails competitive opponent in Cecilia Pitiseni who will put her opponent to the test.

Pitiseni boasts a fight record of 10 Fights with 2 Wins, 7 Losses, and 1 Draw. Boxing Fans are in for a royal treat when the bell rings on this Epic Mama Rocks WIB Bill.

CAROLINE RABALI (LIM) VS WENDY GCADU (KZN) (UNDERCARD)

Caroline Rabali makes her debut and hopes to spring a surprise against a formidable opponent in KZN Boxer Wendy Gcadu with an unbeaten, unblemished record 3 Fights, 3 Wins. It will be nonstop action and both boxers will aim to win this encounter. Catch this exciting bout on Mama Rocks WIB Bill.

This is a massive contest of Cruiserweights and should provide enough entertainment for WIB on this card.

Ngorothe Mugari will hope to make a winning debut against her game opponent in Lillian Molala who does not lack experience having registered 16 Fights, 2 Wins, 12 Losses and 2 Draws.

Fight Fans should anticipate an explosive contest in this bout scheduled for 6 Rounds.

Gudani Mudau, the local favorite, will be looking at making her winning debut in front of a cheerful home crowd but will not find it easy against her KZN opponent, Ntobeko Thusi, who will also be looking at registering a Win for her followers.

AYANDA SIMELANE (SA) VS NOTHANDO NCUBE (SA)

Ayanda Simelane will hope to continue her winning form as she faces a tough opponent in Nothando Ncube. This fight will be a test for both these female boxers as they campaign for favorable ratings in their quest for Flyweight glory.

4.1 SHERADEEN FORTUIN (SA) VS PATIENCE MUSTARA (ZIM)

This is a mouthwatering encounter as two experienced campaigners headline the Mama Rocks WIB Bill and a humdinger in prospect.

Patience Mustara comes into this contest with 18 bouts with 5 Wins, 9 Losses, and 4 Draws.

However, she comes up against a Boxing dynamo and prolific performer in the Former IBO Intercontinental and World Champion, Former WBA Pan Africa Champion, and the current SA Female Bantamweight, Champion Sharadene Sheenzow Fortuin (SA). This international contest is scheduled for 8 Rounds.

LUFUNO MUTSHAYI (LIM) VS ADIDYA MIMU (MALAWI)

This main Supporting Bout pits 2 equally talented Boxers on this exciting bill for an international contest. Adidya Mimu who has a fight record of 3 Fights with 2 Wins and 1 Loss will be hoping to upset Limpopo Boxer Lufuno Mutshayi who is a seasoned campaigner with 12 Fights, 2 Wins, 8 Losses, and 2 Draws.

These 2 Female Boxers will provide plenty excitement as the Boxers will come prepared to fight and impress the judges on this Main Supporting Bout scheduled for 6 Rounds.

The Champion boasts 23 contested Fights, with 7 Wins, 12 Losses, 4 Draws whilst her opponent will come into the fight hoping to maintain her winning streak of 5 Wins in as many Fights.

This Title bout certain to bring the house down as Champion comes up against a challenger who fancies her chance.

RAIDER MULEBA (SA) V BONITA VAN JAARD (SA)

A humdinger of a fight as we witness a local derby for the SA Lightweight Championship scheduled for 10 Rounds. Raider Muleba will be making her first defense against a formidable challenger in Bonita Van Jaarsveldt who will be looking at annexing this prestigious SA Title from the Champion.

Expect both boxers to come to fight as they both have eyes on the main prize of being crowned the SA Female Lightweight Champion on this TLB Boxing Promotions WIB Bill.
