RE: 2023/2024 LICENSING PROCEDURE

1. Purpose

The purpose of this circular is to outline the registration and licensing process for the financial year 2023/2024 to all current and prospective boxing licensees and all boxing stakeholders.

2. Legislative overview

Chapter 1 of the South African Boxing Act, 2001, subsection (g) provides powers to Boxing SA to provide for the registration and licensing of stakeholders in professional boxing and to ensure proper control and democratic practices in the process. Section 7 (1a-y) empowers Boxing SA on the process to be followed when an applicant wants to register as a Boxer, Manager, Trainer, Promoter, Official, Matchmaker or any category as prescribed in the Boxing Act and Boxing Regulations.

The South African Boxing Regulations Section 2-7, further outlines in detail the registration requirements of all categories of applicants. All applicants are therefore encouraged to study and understand the above legislative prescripts before commencing with the registration process as they will be enforced. The above documents are available on the Boxing SA website.

3. Licensing Timelines

In terms of the Boxing Act and Regulations the licences are approved and disapproved by the board, therefore, current and prospective licensees must be aware that they need to apply on or before the closing date to allow the office to compile all the applications to be tabled in the board meeting as per the date below. Licensees are urged to take note of the dates below:

Opening- 01 March 2023	Opening and closing date for all applications and renewals. Applications to be captured on the Boxing SA website (Register Online Tab).
Closing – 21 April 2023	
March – April	Training and Examination of prospective licensees and capturing of license cards. Schedule to be published.
End of April 2023	Special Board meeting to approve all applications and renewals
End of April 2023	Publication of preliminary list of approved licensees
End of April 2023	Publication of the final list of approved licenses for 2023/2024 financial year
May 2023	Distribution of Boxing SA Licence cards. Provincial Schedule to be published.

All applications will be done online, and no manual applications will be processed for all categories.

Those applicants with challenges must contact Provincial Managers at their respective provinces or the office to be assisted for their applications, (see contact details below).

NB: The online application is available on the Boxing SA website (www.boxingsa.co.za), under licensing. Please take note of the enhancements that require bank details and attachment of proof as well as the education qualifications. Boxers must make sure that they upload new medical records

4. 2023/2024 Tariffs

The applicants must take note of the tariffs below and must pay according to the correct category of the license that one wish to apply for. The Act allows applicants to apply for one category of licence as there is a firewall between categories. Please make sure you use a correct reference number. Each reference number is unique to each profile and applicants are encouraged to be specific with this process of referencing.

NB: Please note that there will be a 10% reduction fee for all the licensees who were registered during the 2021/2022 period. All those who were not registered during this period must pay a full fee.

This also applies to new applicants intending to be licensed in the categories as part of the requirement for approval of their licenses.

2. The training and testing schedule is as follows:

2.1 For Gauteng, Limpopo, Mpumalanga, Free State, Northern Cape and North West:
(The training and assessment will be facilitated in Gauteng)

- 2.1.1 Ring Officials: 22-23 March 2023.
- 2.1.2 Managers and Trainers: 27-28 March 2023.
- 2.1.3 Promoters: 29-30 March 2023.

2.2 For KwaZulu-Natal Province:

- 2.2.1 Ring Officials: 1-2 April 2023.
- 2.2.2 Managers and Trainers: 3 -4 April 2023.
- 2.2.3 Promoters: 5 -6 April 2023.

2.3 For Western Cape

- 2.3.1 Ring Officials: 11-12 April 2023.
- 2.3.2 Managers and Trainers: 13-14 April 2023.
- 2.3.3 Promoters: 15-16 April 2023.

2.4 For Eastern Cape:

- 2.4.1 Ring Officials: 18-19 April 2023.
- 2.4.2 Managers and Trainers: 20-21 April 2023.
