Once more it is that time of the year where we put in place the final preparations for the next year's license renewals and new applications. This important information below is therefore of extreme importance to consider as you plan for the 2020/2021 license renewals or registrations.

Purpose

The purpose of this memo is to announce the licensing period, process and related tariffs for the 2020/2021 financial year.

1. Licensing Timelines

Licensees are urged to take note of the following dates:

4 November 2019 – 28 February 2020	Opening and closing date for all new registrations and renewals.
20 March 2020	Special Board meeting to approve all new registrations and renewals.
26 March 2020	Publication of the preliminary list of approved licensees.
1 April 2020	Publication of the final list of approved licensees for 2020/2021 financial year.

Applications and renewals will close on 28 February as opposed to 31 March as it was previously the case. The adjustment is to allow BSA to use the month of March to process all applications, facilitate approval from the Board and release all approved applications by the beginning of the new financial year, i.e. 1 April 2020. In addition to this, the month of March will be used to create identification cards for all licensees whose applications have been approved.

Please note that should you miss the closing date of 28 February 2020 you may still submit your application till 31 March 2020; however, your application will only be tabled for Board approval in the Board meeting scheduled for May 2020. The implication thereof is that individuals who miss the 28 February closing date will not be eligible to participate in any boxing activities till after the approval in May. You are therefore encouraged to submit your applications before aforementioned the closing date.

NB: Any other late applications shall only be considered during quarterly Board meetings .i.e. July and October and such applications may be subjected to a late penalty fee. No late application will be considered beyond the October Board meeting.

2. BSA Licensing Forms

The latest licensing forms are available on the BSA website www.boxingsa.co.za. No other forms other than those found on the website will be accepted.

3. Tariffs

4. Licensing Application and Renewal Requirements

4.1 The following are standard requirements for the registration or renewal across **all categories**, except Promoters.

- Registration/Renewal Form (Annexure A)
- 2x certified copy of ID document (new applicants only)
- 2x passport size colour photo (new applicants only)
- Medical Examination Form (Boxers only)
- Medical Reports (HIV and Hepatitis)
- Bank confirmation letter (not bank statement)

4.2 The following are documentation required for the registration and renewal of **Promoters**.

- Registration/Renewal Form (Annexure A)
- 2x certified copy of ID document (new applicants only)
- 2x passport size colour photo (new applicants only)
- Certified Company Registration Certificate
- Certified SARS Clearance Certificate

Please note:

- All identity documentation copies must be certified at the Police Station or Commissioner of Oath and not older than three (3) months.
- Boxers aged 35 and above, who have not previously submitted a copy of a brain scan (CT/MRI), will still be required to do so before participating in any fight. The copies will be kept on file and considered valid for a minimum period of at least 5 years.
- BSA will not accept incomplete documentation or accept applications with outstanding documentation.

- Payments without submission of application form/s will not be considered for approval and such cannot be accepted as compliant applications.

5. Licensing of Non-South African Citizen

Non-South African citizens who are holders of either a **Permanent Resident Permit, Section 24 Asylum Seeker Permit or Green Refugee ID document**, which allows the holder to work in South Africa will be licensed by BSA. Boxers who fall under this category are, however, not eligible to contest for a South African provincial or national title as per prescripts of the Boxing Regulations but are eligible to participate and benefit from the BSA Safety Fund. Licensing for other categories such as Managers, Trainers and Promoters will also be considered by BSA with specific minimum requirements where applicable.

The licensing of all non-SA citizens will be processed strictly by the BSA office in Pretoria every **Wednesday and Friday** from 10h00 to 16h00, starting from **4 November 2019 till 28 February 2020**. All Gauteng based Boxers, Managers, Trainers, Promoters, etc., who fall under this category are required to present themselves at the BSA office in Pretoria. For all other provinces, please submit your documentation to your respective Provincial Managers who will submit the applications on your behalf.

Over and above the standard required documents, the following documentation is required for the registration/renewal of non-SA citizens across all categories.

- Certified copy of Permanent Resident Permit/Section 24 Asylum Seeker Permit* or Refugee Identity Document
- Certified copy of passport
- Bank account confirmation letter (not a bank statement)
